Örestadskyl was established in 1995 and has a high degree of expertise in cooling, chilling and heat pump technology, as well as specialist expertise in energy reclamation. The company, which has offices in Malmö and Lödeköpinge, works primarily with construction, installation, service, coolant management and energy savings projects. Its customer base comprises primarily major property companies. Annual sales total approximately SEK 30 million, but Assemblin believes it has significant potential for growth.
